What members can receive and do:

- 1. The representative has the right to manage Muaythai business operations in the appointed country.
- 1.1 Members can open Muay Thai technique training seminars at the member's training location. You can request a trainer from the association. and can help train the income and expenses are agreed upon each time.
- 1.2 Membership is open to those interested in training as a professional Muay Thai trainer to provide a "Training Certificate". Training will take place at the association's Muay Thai training center in Thailand only.

Alternatively, the training program may be conducted in the representative's country, subject to the association's approval. After deducting training-related expenses, the remaining proceeds shall be shared based on mutual agreement.

1.3 Muay Thai Referee Training Seminar to provide a "Training Certificate". Training will take place at the association's Muay Thai training center in Thailand only.

Alternatively, the training program may be conducted in the representative's country, subject to the association's approval. After deducting training-related expenses, the remaining proceeds shall be shared based on mutual agreement.

- 1.4 After becoming a member, it is the member's responsibility to organize at least one annual training seminar for Muay Thai referees and instructors, held at a training facility certified by the association or at a location deemed appropriate by the association.
- 2. Member representatives have the right to send boxers to compete in WPMTA association programs around the world.
- 3. The names of the members will be announced on the Association's website, and those interested in becoming members can register members in their respective areas or countries. The membership fee will be divided at a ratio of 70/30 between the country representative and the Association.

- 4. Request to use the W.P.M.T.A. logo: Members must submit a written request for permission each time. If the logo is used on clothing or Muay Thai equipment or for other purposes, the member is required to pay a logo fee at a rate of 10% as agreed upon. If the logo is used without permission, the Association will immediately revoke the membership status.
- 5. Use of the Association's logo for the establishment of training centers: Members must submit a written request for permission along with evidence of the location used for the establishment. If the logo is used without permission or for other purposes, the Association will charge an annual fee of 12,000 Baht.
- 6. Members will receive updates and can regularly participate in various activities of the Association.

The conditions are subject to the regulations set by World Professional Muay Thai Association (WPMTA).

Conditions for competition organizers wanting to use the WPMTA belt

- 1. Inform details of the competition, date, time, championship belts, how many divisions and which divisions?
- 2. Expenses paid to the association; details as follows:
 - 2.1 Annual Registration yearly USD 200
 - 2.2 Promoter fee USD 500
 - 2.3 Sanction fee 1 belt = USD 500 (Championship 3 belts = USD500x3)
 - 2.4 WPMTA Championship Belt Fee
 - 2.4.1 Price per belt: USD 1,000

(This pricing applies to national and continental championship events)

(This rate applies only in cases where the championship belts are produced by

World Professional Muaythai Association (WPMTA))

- 3. Expenses and Allowances for Judges and Referees
- 3.1 Each judge and referee (3 persons required) shall receive a fee of USD 300 per person, totaling USD 900 for one event. A minimum of three licensed officials is required for each championship bout.
- 3.2 The event organizer shall be responsible for the travel expenses, meals, accommodation, and other related costs of the judges and the referees officiating in the ring.
- 4. VIPs of the association Award belts or be honored at events the organizer is responsible for the expenses.
 - 4.1 Round-trip plane ticket
 - 4.2 Visa processing fee
 - 4.3 Accommodation and food
 - 4.4 Travel shuttle service
 - 4.5 Allowance USD 1000 / 1 Vip and 1 Follower

- 4.6 The event organizer shall be responsible for the expenses of any accompanying persons as well.
- 5. Couples competing for the WPMTA belt
- 5.1 Foreign boxers who are not Thai boxers The organizer must send the boxer's history to the association for their acknowledgment and consent.
- 5.2 If you are a Muay Thai boxer competing in a show, the WPMTA Association will select the boxer and opponent, as well as request permission from government authorities to send the boxer to compete in the event.
- 6. The duties of the association's representative in each country:
 - 6.1 Organize national-level competitions.
 - 6.2 National Champions League.
 - 6.3 Organize at least one coaching or officiating seminar per year.
- 6.4 Each representative from every country should plan and organize at least one event per year, following the association's guidelines, and notify the association of the plan in advance.
- 7. You must submit high-quality images and videos to the WPMTA Association within 7 days after the competition.
- 8. WPMTA Association has the right to use media, images, videos, and audio for promotional purposes.
- 9. The applicant must be approved during the association's board meeting.
- 10. Applicants must strictly comply with the rules and regulations of the association. Failure to comply with the association's terms and conditions may result in the termination of representative status without prior notice. In the event of any legal violation, the association shall not be held responsible for any resulting damages and will take legal action as strictly required by law.
